Review of Minutes

There was no review of the previous meeting's minutes; they were reviewed by the Board and posted online.

Treasurer's report

Bev Borden presented the Treasurer's report, which is also on-line. Note that one bill for facilities work will be reimbursed by IRDF, so it also shows up on the income side.

FSILG Office / DSL, and Council updates

Liz Jason reminded the AILG that FSILG is now fully staffed, including the admin staff. Jessica said that PanHel is collaborating with the IFC on sexual assault prevention to implement real change. This is also officer transition season. Anthony Dominguez is attending today, introducing himself, working with the IFC.

Revisit of AILG Focuses

One focus is designing the Member Support program to assist organizations in contrast to the Peer Visit Program. There are three main tasks of this program: 1) Finding what are the risk factors of concern, 2) identifying organizations that may be at risk, 3) devising the process to help such organizations. Another focus is the sustainability working group, which would help understand the present campus experience with an objective of strengthening FSILGs. Finally, the Board will be reviewing the by-laws. There will be a signup for the first two items.

The Third Annual Bob Ferrara Leadership Retreat

The retreat is scheduled for January 28 at the MIT Endicott House. A formal agenda will come out in December or early January. The board especially wants living groups to encourage graduating seniors to attend. Much of the focus will be on sustainability and awareness of campus conditions.

IRDF Policy updates

Pam Gannon went through a presentation that is posted on the AILG web site. One update to the policy was to clarify the intention of the IRDF project grants focus on livability, safety, and education. The revised educational area calculation resulted in increased education area fractions. The maximum for minor project grants will be \$50,000.

Updates to the SLI Program Specification

Larry Stabile described the updated specification, which is available on-line at http://ailg.mit.edu/committees/facilities-committee. See the web site for details of the changes. There was a motion to amend the specification to enable organizations to modify SLI documents, requiring a change to the FCI web site. An amendment was proposed as a motion, which was not accepted by an 18 to 7 vote with 1 abstention. The motion to accept the updated (unamended) specification passed 24 to 1 with 1 abstention

Other Business

Pam Gannon reported on progress of the Facilities Renewal program, which is ongoing. An update will be presented at a future meeting.

News from the FCI included adding Nellie King to the staff and notice that IRDF minor project grants are due Dec. 1.

Announcements

Liz announced that there will be a 'winter prep' meeting relating to windows, heat, securing doors, etc and that we should all talk to the undergraduates about security during the holidays.

The next Board meeting will be followed by the annual AILG "holiday party". All AILG members arewelcome to attend. The original proposed date, 12/8 conflicts with an MIT Quarter Century Club dinner, so the date was set for 12/1/22. After the meeting, it was decided that it would be held at the Cambridge Brewery.
