Review of Minutes

Minutes from March 2 meeting were reviewed and approved pending minor corrections.

Treasurer's Update and Financial Report

Bev presented the current finances. There are some expenses still to arrive from the Peer Visit Program as reviews are taking place this weekend. The main topic was the presentation of the proposed budget for 2023-24. AEPi is dropping one building from the BSF and SLI program. One question arose about who are members. In accordance with Article I, Section I, the following motion was passed unanimously:

The board resolves to notify AEPi that due to prolonged inactivity, effective immediately, AEPi is no longer recognized as an active member of the AILG; therefore as indicated in bylaws article 1 section 1, they cease to be a member. If in the future, the organization intends to reestablish on MIT's campus, they may again be eligible for AILG membership.

FSILG Office and Council Update

Liz reminded everyone about the FSILG rewards ceremony. She updated the group about the status of the request for LCA to return to campus. An issue from CPW was discussed that resulted in a discussion as to how many students (who are minors) should be hosted in any given building. There was some discussion about criteria for hosting that may be connected to building conditions.

Annual Initiative Recap

Member support: Alex said that we still could use another person for the activity.

Committee Reports

Facility Renewal: Pam invited 13 houses for the next phase and 8 have agreed.

Facilities: Pam reported for Larry Stabile. Inspections are more assiduous regarding sprinkler inspections and there is an initiative to improve safety-related signage.

Annual meeting planning

Nominating committee: Pam reported that all the ombudspersons are willing to renew and that Board members are also willing to renew.

Special invitations: Pam has a list of folks to invite and is ready to send the invitation!
